Liquid Cationic Polymer

- **Needs less energy to form a floc than other polymers**
- **Enhances effluent turbidities**

- **Increases filter runs through lower settled water turbidities**

## Principal Uses

Sweetwater 8808 is used as a primary coagulant or coagulant aid in the treatment of potable or industrial water or wastewaters. It has been approved for use in potable water by the National Sanitation Foundation for use in treating potable water. Sweetwater 8808 can also be used as a filter aid where a cationic charged polymer is appropriate. When used as a coagulant aid, Sweetwater 8808 has been shown to significantly reduce or eliminate the need for inorganic coagulants such as alum or ferric chloride. Unlike other cationic polymers, Sweetwater 8808 has shown the ability to form a floc particle under low energy mixing conditions.

Conventional	1 - 10 ppm
Direct Filtration	.1 - 2 ppm
Filter Aid	.02 - ppm

## Feeding

Sweetwater 8808 can be fed as a neat solution or as a dilution. Optimum results are achieved through dilution of 10:1 or more. However, the penalty of feeding the product on a neat basis is not severe.

## Handling and Storage

Sweetwater 8808 is not considered hazardous, however, care should be taken to avoid spills as the product is somewhat viscous. Avoid contact with eyes or skin. Avoid prolonged or repeated breathing of vapors and do not take internally.

Sweetwater 8808 can be stored in unopened containers for up to one year. Bulk 8808 should be stored in lined steel, fiberglass or cross linked polypropylene tanks. Stability of diluted 8808 is significantly less than neat 8808. Dilute solutions of less than 10% are stable for a period of about one week.

## Shipping

Sweetwater 8808 is available in either drum or bulk quantities from various locations around the United States.
